Booking

When booking your bridal party, we will require a complete bridal contract with the following information:

- *First and last name of each client.
- *Phone number of each client.

*Service(s) and requested stylist/artist.

*credit card(s) that will be valid for the day of the wedding and/or explanation of payment.

Securing appointment date

Your appointment date(s) will be scheduled when a signed contract and deposit has been received.

Deposit

All reservations require at least a \$50 deposit per service provider and ONE credit card to hold appointments.

Contract/Appointment Changes

Failure to cancel your appointment within 7 days will result in forfeiture of deposit. Any changes MUST be approved and scheduled prior with salon staff. Further charges may apply

Hair and makeup consultations are scheduled for 15 minutes and are complimentary. At that time we will discuss styling options and go over the bridal contract with you. These appointments can be made at anytime.

Trial runs for the Brides hair and makeup are mandatory and will be done by appointment. At that time we will do a run through of the style you have chosen. This allows us to make any necessary changes needed before your wedding day. Trial runs for bridesmaids are optional.

Special instructions for the Bride and her Wedding Party

Stylist schedules can be tight for bridal parties. Please arrive on time to ensure ample time is provided.

Before the Wedding:

We recommend that you book your consultation or a trial run with your stylist at least 2 weeks prior to your wedding. **Bride trial runs are required!**

Bring any hair accessories or extensions you plan on using for the wedding. It's also a good idea to bring photos of your dress and a few potential hairstyles.

Any haircutting or coloring should be done 1-2 weeks prior to the wedding.

The day before the wedding:

Shampoo and blow dry your hair with minimal product. **NO flat ironing** as this can affect the way your hair will hold or curl the following day.

Wedding Day:

Those booked for updos: **Do not** wash your hair the same day as your appointment. Please arrive to your appointment with dry hair.

We recommend wearing a button down or zippered shirt that does not go over your head.

Refreshments are not provided by Eden Salon. You are more than welcome to bring your own.
